Self-archiving policy ('Green OA')

Non-Open Access Titles

Our self-archiving policy applies to research books across all our academic imprints: Bloomsbury Academic, Bloomsbury Visual Arts, Bloomsbury Libraries Unlimited, Methuen Drama, Arden Shakespeare, T & T Clark and Hart.

We permit self-archiving of non-open access chapters published in these imprints subject to the following conditions.

- When archiving your chapter, we ask that you provide a citation to the published work and link to the published version of the book on bloomsburycollections.com.
- Chapter manuscripts may be archived in a repository immediately on acceptance, providing they are not made publicly accessible until after the embargo period. This is sometimes referred to as a 'closed deposit'.
- Chapters by different authors from a single edited collection may not be archived on the same web page.
- Ahead of archiving your chapter please ensure that you have completed and returned [this form](#) to claire.weatherhead@bloomsbury.com.

Please note that self-archiving is not currently offered for content published in Bloomsbury major reference works (MRWs), including our Cultural Histories series, or for commissioned articles published on the Bloomsbury Digital Resources platforms.

Open Access Titles

Where titles are published via our open access programme, the version of record (VoR) of the complete chapter or work may be archived immediately on publication. In the case of retrospective open access titles, the complete work may be self-archived as soon as the open access version has been published.

Definitions

Accepted manuscript

The version of the manuscript accepted for publication, after peer review and any subsequent revisions, but prior to copyediting or typesetting by the publisher.

Version of Record

The final published version of the work, following copyediting and typesetting by the publisher.

FAQs

Can I self-archive my work on Academia.edu or ResearchGate?

As Academia.edu and ResearchGate are commercial networks rather than repositories, self-archiving of chapters from Bloomsbury books that have not been published open access is not permitted on these sites.

Authors of open access books may share the version of record on any network or website, including commercial sites such as Academia.edu and ResearchGate.

How do you define 'commercial' and 'non-commercial' repositories?

Non-commercial repositories are those maintained by non-profit organizations, such as academic institutions, research funders, and scholarly societies; typically these are the only repositories that meet funders' self-archiving requirements. Commercial repositories and academic social networks are those that make a profit from hosting archived content, for example by selling data or advertising.

I am UKRI-funded and need to self-archive my chapter under a Creative Commons licence – is this possible?

In addition to our standard self-archiving terms, where individual chapters are subject to UKRI's open access policy authors may deposit their accepted chapter manuscript in a compliant repository and make it publicly accessible 12 months after publication under a CC BY-NC-ND 4.0 licence. You will need to submit a formal permissions request: please contact your editor who will send you the appropriate form.

My funder has other self-archiving requirements that exceed Bloomsbury's policy – can you make an exception?

We are keen to support our authors in complying with funder requirements. Please contact your editor to discuss your individual case.

I have written multiple chapters for an edited collection or handbook. May I self-archive all of these?

Yes, authors who have written multiple chapters may self-archive all their chapters.

My work was published by a former imprint that is now part of Bloomsbury Academic – does the self-archiving policy apply to me?

If your work was original research published in a monograph, edited collection, or handbook, you may self-archive in accordance with the policy on this page. If you are unsure of whether the book meets these criteria, please [contact the relevant editor](#).

How can I access a copy of my chapter for self-archiving purposes?

- **Accepted Manuscript:** If you are self-archiving the manuscript/typescript version of your chapter, you should already have a copy in your files or email history (it will be the final version you submitted to Bloomsbury for publication). Unfortunately we are not able to supply manuscript files to you for self-archiving purposes.
- **Version of Record:** If your institution has purchased a digital edition of the book via our ebook platform [Bloomsbury Collections](#), you will be able to download a copy of your chapter from here: search for the title, scroll down to see the full table of contents, click into the relevant chapter, and select 'Download' from the menu on the top right. If you do not have access via Bloomsbury Collections, please contact your editor to request a copy of the PDF.
